

# LIMITED WARRANTY

## COMMERCIAL / AGRICULTURAL WALK DOOR

AJ Manufacturing, Inc. warrants its Commercial / Agricultural walk doors (the "Product") against defects in material and workmanship for a period of five (5) years from the date of the original retail purchase.\*

Should the Product, be otherwise than warranted during the period specified above, AJ Manufacturing, Inc. will repair (or at its option replace) the defective Product during the warranty period at no charge to you, provided the Product is returned to an authorized AJ Manufacturing, Inc. Distributor within twenty-four (24) months from the commencement of the warranty period. In the event the Product is returned subsequent to the expiration of the first twenty-four (24) months of the warranty, and in the event AJ Manufacturing, Inc. elects to replace rather than repair the defective Product, you will be charged the following, to-with:

<u>Months</u>	<u>Percent of Replacement Cost</u>
0 - 24	No Charge
25 - 36	25%
37 - 48	50%
49 - 60	75%
61 and up	100%

In order to obtain warranty service, you must return the defective Product to an authorized AJ Manufacturing, Inc. Distributor. (You can obtain the name and address of an authorized Distributor from AJ Manufacturing, Inc. directly at the address printed on this certificate.) AJ Manufacturing, Inc. shall not be responsible for any transportation costs for the return of the defective Product to the Distributor nor the return of the repaired or replacement Product to you from the Distributor. AJ Manufacturing, Inc. shall not be responsible for labor costs associated with the removal of the defective Product nor will it be responsible for labor costs related to the reinstallation of the repaired or replacement Product.

This warranty specifically does not apply to:

- a) Alteration, or damage caused by misuse, negligence, accident, or acts of God;
- b) To any defects of any nature whatsoever in any of the hardware which if furnished with the Product which was not manufactured by AJ Manufacturing, Inc.; and
- c) To any glass breakage.

As to the hardware provided with the Product, AJ Manufacturing, Inc. makes no warranties, express or implied, including but not limited to, warranty, including any damage to property, and to the extent permitted by the law, damages for personal injury. Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitation on how long an implied warranty lasts, so the above limitation or exclusion may not apply to you.

This warranty shall not be applicable to the extent that any provision of this warranty is prohibited by any federal, state, or municipal law which cannot be preempted. This warranty gives you specific rights, and you may also have other rights which vary from state-to-state.

\*In the event you cannot offer documentary proof of date of retail purchase, the date of the manufacture shall be the warranty commencement date.
