

**LIMITED WARRANTY**  
**Aluminum Windows & Main Street Vinyl Windows**

AJ Manufacturing, Inc. warrants its windows (the "Product") against defects in material and workmanship for a period of one (1) year from the date of the original retail purchase.\*

In addition to the limited warranty provided here, AJ Manufacturing, Inc. warrants that any insulating glass component of the Product shall under normal conditions of use and service remain free from material obstruction of vision resulting from film formation or dust collection between the interior surfaces of the insulating glass caused by failure of the seal other than through glass breakage for a period of five (5) years from the date of the original retail purchase.\* Should any portion of the Product be otherwise than warranted during the period specified above, AJ Manufacturing, Inc. will repair (or at its option, replace) that portion of the Product found to be defective during the warranty period at no charge to you, provided the defective portion of the Product is returned to an authorized AJ Manufacturing, Inc. Distributor within twelve (12) months from the commencement of the warranty period of five (5) years in the case of defective insulating glass.

In order to obtain warranty service, you must return the defective Product to an authorized AJ Manufacturing, Inc. Distributor. (You can obtain the name and address of an authorized Distributor from AJ Manufacturing, Inc. directly at the address printed on this certificate.) AJ Manufacturing, Inc. shall not be responsible for any transportation costs for the return of the defective Product to the Distributor nor the return of the repaired or replacement Product to you from the Distributor. AJ Manufacturing, Inc. shall not be responsible for labor costs associated with the removal of the defective Product nor will it be responsible for labor costs related to the reinstallation of the repaired or replacement Product.

This Limited Warranty specifically does not apply to:

- a) Alteration or damage caused by misuse, negligence accident, or acts of God;
- b) To any defects of any nature whatsoever in any of the hardware which if furnished with the Product which was not manufactured by AJ Manufacturing, Inc.; and
- c) To any glass breakage.

As to the hardware provided with the Product, AJ Manufacturing, Inc. makes no warranties, express or implied, including but not limited to, the implied warranties of merchantability and fitness for a particular purpose. Any implied warranty of the Products covered by the express warranty, including warranty of fitness for a particular purpose or warranty of merchantability is limited in duration to the express warranty provided herein unless a shorter period is permitted by law. AJ Manufacturing, Inc. shall not be responsible for incidental or consequential damages resulting from the break of any express or limited warranty, including any damage to property, and to the extent permitted by law, damages for personal injury. Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitation on how long an implied warranty lasts, so the above limitation or exclusion may not apply to you.

This warranty shall not be applicable to the extent that any provision of this warranty is prohibited by any federal, state, or municipal law which cannot be preempted. This warranty gives you specific rights, and you may also have other rights which vary from state-to-state.

\*In the event you cannot offer documentary proof of date of retail purchase, the date of the manufacture shall be the warranty commencement date.
